Eanes ISD makes use of competitive contracts in compliance with Texas law for purchases of goods and services when expenditures are estimated to be in excess of \$10,000 for a commodity category in a twelve month period. Competitive contracts are established by means of an RFP issued by Eanes ISD or the use of an approved, competitively awarded, purchasing cooperative contract. In a few rare instances, a sole source contract may be used when it is in compliance with the laws of the State of Texas.

This application provides a method for vendors to make Eanes ISD aware of their desire to do business with the district. It is the responsibility of the vendor to update the information as needed.

Submission of an Eanes ISD Prospective Bidder Application does not entitle a vendor to sell to Eanes ISD. Vendors are awarded a contract only through the statutory competitive procurement process.
