NEW STUDENT ENROLLMENT CHECKLIST FOR 2016-17

In addition to completing the online enrollment, the following documentation is needed for each student at the time of enrollment. Please submit the documentation directly to the school office. **A student will not be permitted to start school and will not be placed in a class until the required documentation is received.** Required documents can be found at <http://www.eanesisd.net/enroll2>

<u>Information REQUIRED at Time of Enrollment</u>	<u>DOCUMENTATION INSTRUCTIONS</u>
___ 2 Proofs of Residency	(1) Current Signed lease, deed or contract, or most recent tax receipt AND (2) Current Utility for the property in the parent/guardian's name Transfer Students: Provide copy of acceptance e-mail/letter
___ Birth Certificate	State law requires schools to have proof of a child's identity and age on file.
___ Social Security Card	If no social security card, please communicate to Registrar at time of enrollment.
___ Valid Driver's License	State law requires a driver's license or valid state ID. Eanes ISD requires that the ID have the same address as your proof of residency. You have 30 days from the date of registration to provide a license with the correct address to the Registrar's office.
___ Immunization Record	Immunizations must be up-to-date. A copy of the child's immunization record or an EISD Certificate of Immunization form is required. The record must include the month, day and year for each vaccine <i>and</i> a physician signature or clinic stamp. REQUIRED Only if Applicable The following information is required at time of enrollment if the situations apply to the student.

___ Special Education/ 504 Records if applicable	If a student receives Special Education or 504 services a copy of the current services records is required.

ANAPHYLAXIS, ASTHMA, DIABETES, SEIZURES and OTHER CHRONIC HEALTH CONDITIONS

If your child has a condition that COULD require treatment at school, please: (1) notify the school nurse; (2) ask your child's doctor to complete an EISD emergency care plan/action plan that prescribes and authorizes treatment; (3) sign the form, yourself, to authorize treatment; and (4) bring the form and medications to the school nurse *before* the first day of school. ___ Allergy/Anaphylaxis Emergency Care Plan	This form must be completed by the child's physician if the child has a <i>life-threatening</i> allergy
___ Asthma Action Plan	This form must be completed by the child's physician if the child is being <i>treated</i> for asthma

REQUIRED Secondary The following information is required for students entering grades 6 through 12.
 (grades 6-12 only)

___ Unofficial Copy of Transcript	If a student entering grades 7 through 12 has taken high school credit courses an unofficial copy of the student's transcript is requested at the time of enrollment.
___ Most Recent Report Card	The most recently completed report card is required. Plus (Middle school only) prior 2 years' report cards if available.
___ Standardized Test Scores	The most recent standardized test scores. Plus (middle school only) prior two years' test scores if available.

REQUESTED HEALTH DOCUMENTATION

___ Physician's Report	A physical exam is strongly recommended when enrolling in Kindergarten.
