- Nurses - reviewed the roles of nurses during COVID
- Homebound Services - working with individual families
- Maram Museific - offered support at the local and state level as a resource; thanked district for their support

## **Legislative Update**

- **Molly May**

Molly May provided an overview of various legislation that seemed pertinent to SSHAC this year. Brad Shields provided additional information about some legislation and the calling of a 3rd special session. Both Molly and Brad mentioned that it will be important to keep following the legislation and how it intersects with SSHAC.

HB 1525 - SHAC and Human Sexuality  
HB 699 - Life threatening illness and absences  
HB 1080- UIL & Mental Health  
HB 1535 - Low Use Cannabis  
SB 179 - Counselor Work Time  
SB 2050 - Bullying

There was some discussion around the adoption of the Human Sexuality curriculum and timelines. Molly is looking into timelines and felt SSHAC would be important in looking at the health curriculum adoption for next year. There was also discussion around SSHAC having a role in developing a survey around bullying if there isn't something provided by the state.
