I think many of you have seen this schedule. So for students who are included in the 25% and returning to campus those parents have already received information and a letter that says they are returning 34 00:05:14.850 --> 00:05:21.180 Staci Hubbard: If you did not receive a letter then you will not be returning at this time. So the students that are returning 35 00:05:22.380 --> 00:05:35.490 Staci Hubbard: Our school day begins at 7:45 and ends at 11 so we want kids to be dropped off as close to that as possible and picked up as close to 11 as possible. Staci Hubbard: In-building students are the identified as the initial 25%, they'll engage with specials in the afternoon remotely during their assigned time slots or their timeframe. And that's from one to four. We are not going

to have students go out and do recess on the playground. So in the lower car, you're going to enter and it can be really confusing at the lowest car, a lot of parents 88 00:14:48.630 --> 00:15:00.990 Michelle Corbett: Want to turn in that area that's right by the cafeteria. And so if we have cars turn in there and cars coming on Eanes school road, we have cars going in both directions. So we do want you to enter into that lowest 89 00:15:01.350 --> 00:15:13.110Michelle Corbett: Car line on Eanes school road and then you circle around and you will be picking your students up right by the cafeteria and then exiting out on to camp craft road. 90 00:15:13.710 --> 00:15:29.280 Michelle Corbett: For the middle car line area, there is an area there that you can turn in that's in the middle of in between Eanes school road and up on BK bro, that's where you will turn in for middle car. Michelle Corbett: And so when you're picking them up, you would put that in your front windshield. Your child will have on a mask, we will have on a mask. So we're talking about signing a student out early because of illness. If a case of COVID-19 is confirmed the classroom or school area will be thoroughly cleaned. So our guidance. What we're taking from that close contact should follow the stay at home product protocols outlined by the CDC. 228 00:39:58.170 --> 00:40:10.440 Cindy Seferian: COVID-19 testing for close contacts is not necessary as negative test results can occur. Anytime, while the viruses incubating this virus incubates for 14 days. Maybe you need a ruler and it could be a number of things, but not that whole box. So I want to let you know that the 25% have already been notified. I would recommend that you also show your children those slides. Everyone removing their masks at the same time to eat a snack doesn't feel safe. How do you plan 308 00:53:18.120 --> 00:53:24.300 Lesley Ryan – EE: To do snack time safely in the classroom and I appreciate you asking that, you know, safety is our number one priority. 309 00:53:24.870 --> 00:53:32.010 Lesley Ryan – EE: For students and for staff, I would tell any student that who asked, you know, my number one job is to keep you safe followed very closely by 310 00:53:32.550 --> 00:53:42.570 Lesley Ryan - EE: High levels of learning. So our plan for that. There are a couple of options that we're going to talk through with teachers and it may look different from class to class, depending upon how many students there are 311 00:53:42.870 --> 00:53:45.690 Lesley Ryan – EE: You know, I think I have six students coming in. 312 00:53:46.260 --> 00:53:55.170 Lesley Ryan - EE: To Mr Polly's kindergarten classroom, which is different than having 12 students coming in and just Ballard's third grade classroom. So the spacing within the classroom.

We have even said before, a student goes into the bathroom they sanitize their hands and of course when they come out. We want them to wash their hands. 317 00:54:30.960 --> 00:54:35.790 Lesley Ryan – EE: And we will practice that often here, and we've talking to students and 318 00:54:36.300 --> 00:54:43.620 Lesley Ryan – EE: We've talked about having a little light outside of the bathrooms that you press and they turn on and we're going to encourage them to use their elbows. 319 00:54:44.040 --> 00:54:52.950 Lesley Ryan – EE: To turn that light on so that there's one person in the bathroom at a time. If you come into the center of our pod. For those of you who are new to us. We have four classrooms. 320 00:54:53.280 --> 00:55:02.190 Lesley Ryan - EE: And in a building and the bathrooms in the center. And there are two of those. And so that with the light is on, it means the bathrooms occupied

So we're thinking through even lights and we 322 00:55:11.790 --> 00:55:21.930 Lesley Ryan - EE: We're thinking about Bucees. If you've ever been to the bathroom at Bucees, you'll know that they have lights above the bathroom stalls to let you know whether a bathrooms available or not. So that was our Bucees idea. 323 00:55:24.090 --> 00:55:27.300 Staci Hubbard: So one of the questions was related to 324 00:55:28.680 --> 00:55:41.250 Staci Hubbard: If, if a whole class had to isolate and who would have to isolate and some of that is going to depend going to depend. But one of the things that our nurse talked about is 325 00:55:42.390 --> 00:55:50.280 Staci Hubbard: If you're within six feet for more than 15 minutes or more that's considered 326 00:55:51.780 --> 00:56:03.750 Staci Hubbard: Close proximity and then we would have to consider possibly staying home for 14 days. So it just depends on that contact 327 00:56:05.940 --> 00:56:13.650 Lesley Ryan - EE: And I want to go back to something that's going to be important smart tags. So we use that tool for a number of things right, we 328 00:56:13.890 --> 00:56:19.950 Lesley Ryan – EE: Have students, you know, during school year can use that even I know the high school. They use their smart tags to buy their lunches. 329 00:56:20.280 --> 00:56:25.080

Lesley Ryan - EE: And they use it to get on and off the bus, but the system is also something that we use to notify 330 00:56:25.350 --> 00:56:34.470 Lesley Ryan - EE: Our school if you need to either check your student out early. Or if your students going to be absent. Now if your students going to be absent and it's not illness related. We ask that you 331 00:56:35.160 --> 00:56:39.840 Lesley Ryan - EE: enter that in smart tag and then you're good to go. That that's notification for us also let your teacher know. 332 00:56:40.200 --> 00:56:53.310 Lesley Ryan – EE: But if it is illness related. We also ask that you reach out to the school nurse and her email is on on this page as well. And just so that we have that information on campus, so we can be aware of that. 333 00:56:55.200 --> 00:57:03.270 Lesley Ryan - EE: And oh, Mrs Burke, just let me know that she actually Cindy will receive that from smart tag so you don't have to email her separately.
